23rd Annual Potomac River Watershed Cleanup

Saturday April 9, 2011
9am - 12pm

Since 1989, more than 60,000 volunteers have teamed with 375 partner organizations to tug over 3 million tons of trash from the watershed's streams, rivers and bays. Last year's haul of over 250 tons included more than 15 tons of recyclables, 21,597 plastic bags, 1,844 tires, 14,802 cigarette butts, 3 canoes and 2 couches!

The 2010 Cleanup took place at over 500 sites in the District of Columbia, Maryland, Virginia, Pennsylvania and West Virginia – all part of the lands, or watershed, that drain into the Potomac. Locations included fields, forests, parking lots and other 'inland' sites, where the trash can be removed before it enters creeks and other waterways.

Why Participate? The Annual Potomac River Watershed Cleanup has become a decisive catalyst for progress that ignites people throughout the watershed with the Alice Ferguson Foundation's community spirit. The largest regional event of its kind, the Cleanup provides a transforming experience that engages citizens and community leaders and generates momentum for change.

Two Shenandoah Waterways Designated ‘Special Project Areas’
Cedar & Passage Creek Landowners Will Benefit from Additional Land Protection Resources
[Press release dated February 24, 2011 from the Potomac Conservancy]

Winchester (VA) -- Cedar Creek and Passage Creek were recently accepted by the Virginia Outdoors Foundation (VOF) as a Special Project Area. Nominated by Potomac Conservancy, designation of this area will enhance the Conservancy’s land protection efforts in the Shenandoah Valley region, specifically in the headwaters of the North Fork of the Shenandoah River. Enhanced and continued protection of Cedar and Passage Creeks ensures the preservation of local drinking water supplies as well as historic and recreational resources. The area contains fragile ecosystems, rare species, and incredible scenic beauty that should be preserved for enjoyment by generations of Virginians.

Special Project Areas are particular geographic regions in Virginia where the VOF board of trustees determines land protection through easements is especially warranted. Nominated areas are judged using an array of criteria including conservation value and public benefit. Community support is integral to the nomination process, which requires letters of support from community members and organizations, expressing their readiness to proceed. “Over the past year, I reached out to the local communities to both gauge and garner support for this designation,” said Potomac Conservancy Director of Land Protection Kelly Watkinson, who oversaw the nomination process. “I was very encouraged by the enthusiasm and support from local officials, landowners, and community organizations, such as the Fort Valley Ruritans.” For landowners in Cedar or Passage Creek communities interested in protecting their properties with a conservation easement, Special Project Area designation will improve their ranking with VOF, making it more likely for their easement to be accepted.

Considered among the cleanest and least disturbed streams in the Shenandoah Valley, Cedar and Passage Creeks have long been a priority for Potomac Conservancy. The Conservancy currently co-holds an easement with VOF at historic Mount Pleasant Farm, a 106-acre property along Cedar Creek. Concerned about the rapid development around her farm, owner Mrs. Caroline Stalnaker chose to permanently protect her land in 2006 to ensure it remains available for agriculture for future generations. “It’s rather an Island, in a sense, because the land is the only property south of Route 81 that hasn’t been annexed or developed,” she commented. Mrs. Stalnaker continues to live and raise sheep on her farm. She is hoping to have her bed and breakfast operation, *Mount Pleasant 1812*, up and running by April of this year. “The designation of this Special Project Area will enable VOF to more effectively build upon the 1,600 acres that we currently protect in these two watersheds,” remarked VOF easement manager Laura Thurman, who works with landowners throughout the Shenandoah Valley to protect their land.

Hazard on Catoctin Creek (MD)

Several of us enjoyed a leisurely float on lower Catoctin Creek last Sunday — leisurely, that is, until we discovered that the water route under the C&O aqueduct, which is being rebuilt, is blocked with construction equipment, necessitating a class 3, four-pitch, five-canoe, up-over-and-around portage on river-left. At 5.5 on the Little Falls gauge, there was only about 14" of clearance, too little to limbo; however it should be possible to get under when the Potomac drops below 5 feet.

New information about the river (e.g., new hazards) is particularly important. **Photos** are also published. Send prints to the webmaster or e-mail digital photos to the newsletter editor.
